Retaining wall is rotting and needs to be addressed. Bruce has received 2 quotes and plans on getting one more. Quote from Solitude, who does all our existing pond maintenance, had two options, both significant in price. The other quote is from Aqua Doc, which has a different approach to fix the problem, also significant in price. They also sent over a proposal to do the pond maintenance, which was a cost savings from Solitude's yearly cost. Sandi motioned to change vendors on maintenance and all board members seconded the motion. Changing vendors on pond maintenance to save cost was approved.

 Discuss possible dues increase pursuant to pond wall repair quotes and other possible future pond requirements and the need for more general funds

Tiffany M discussed the need to increase dues. To pay our annual budget and not be in the red (which would mean taking from the reserve), we need to increase the dues, so we can stay out of the red, and be able to pay for upcoming costs such as the pond. The pond repairs and requirements are eminent and must be addressed. To be able to pay for the repairs the dues must go up. We need to have a vote in October, and the decision needs to be made by November. Bruce will draw up a letter.
