- There are multiple trees down on the north side of Fairchild Lane and in the pond area. Both of these areas are HHF HOA common areas. Quotes from Hawk Tree Care are \$920 and \$695 respectively. The trees will be cut, moved (where necessary), and left to decay in their respective areas. Some trees are already down and some are leaning. Viet and Bruce will walk the property and mark the trees in order to get one more estimate from another insured vendor.
